POSITION SUMMARY

The Multi Service Technician makes repairs to Ground Support Equipment (GSE) following orders of the supervisor, troubleshooting malfunctions of GSE using conventional and digital multi-meters, voltmeters, ohmmeters, frequency counters, oscilloscopes, circuit card testers, transistor testers, and hand tools, prepares GSE for storage and transportation, uses automated maintenance data systems to maintain equipment records, and document maintenance actions, maintains external fuel and grounding systems. Performs scheduled and unscheduled maintenance on GSE, inspects, tests, and operates GSE to determine equipment serviceability and proper operation, services equipment with fuel, oil, water, coolant, hydraulic fluid, refrigerant, and compressed air, disassembles and assembles malfunctioning GSE accessories and components. In addition, the Ground Support Equipment Worker removes, disassembles repairs, cleans, treats for corrosion, assembles, and reinstalls GSE components and accessories, stencils and marks GSE in accordance with technical publications, stores, handles, labels, uses, and disposes of hazardous materials and waste in accordance with all state, local, and federal environmental standards and regulations.

DUTIES & RESPONSIBILITIES (98% of workers time)

- Work from approved standards or special procedures, manuals, training, shift logs, verbal turnover, and take day-to-day work direction from liquid waste operations supervision
- Attend classroom, on-the-job, and other types of training as deemed necessary
- Steam trap replacement, pipe repairs, pump repairs insulation, valve repairs, and operations support
- Assist in the performance of routine maintenance and operations activities
- Conduct area housekeeping
- Set up and removal of scaffolding, tools and equipment in work areas
- Remove HEPA Filters from Housing and Replace with new filters and assist Qualified operator in performing DOP testing
- Operate Breathing Air Manifolds and Compressors which requires monitoring pressure, connecting and removing hoses

- Assist in waste transfer line segment pressure testing using liquid waste operations supplied test rig
- Transporting waste samples laboratories
- Other general or discipline specific duties as assigned by liquid waste operations supervision

DUTIES & RESPONSIBILITIES (2% of workers time)

- Work in Radiation/Contaminated areas conducting minor maintenance activities while utilizing the appropriate Personal Protective Equipment to prevent exposure.
- Fabricate and Remove containment huts to support work to be conducted in Radiological Areas
- Assist in donning and doffing (cut out) Plastic Suits worn by workers.

MINIMUM QUALIFICATIONS

- High School Diploma
- Minimum of three (3) years Mechanical Maintenance or Plant Operations experience
- Working knowledge of Liquid Waste Operations Critical Maintenance/Operations duties
- Ability to work on-site Savannah River Site
- Ability to work shift work if required

PHYSICAL REQUIREMENTS AND WORK ENVIRONMENT

This position operates in an on-site facility shop and may require standing for extended periods of time. The performance of this position may occasionally require exposure to areas that require the use of personal protective equipment such as protective suit, safety glasses with side shields and mandatory hearing protection. The employee must occasionally lift and/or move up to 25 pounds.
